FEE-SETTING - PARKS & LEISURE SERVICES BYLAW

Bylaw No. 2010, 2001

A Bylaw to Establish Fees and Charges for Parks & Leisure Services

NOW THEREFORE, the Council of The Corporation of the District of Pitt Meadows in open meeting assembled, ENACTS AS FOLLOWS:

1. This Bylaw may be cited as "**The District of Pitt Meadows Parks & Leisure Services Fee-Setting Bylaw No. 2010, 2001**".
2. The District of Pitt Meadows hereby imposes fees for the provision of parks and leisure services and information as set out in Schedules "A", "B", "C" and "D" attached hereto and forming part of this Bylaw.
3. That Pitt Meadows Fee-Setting – Parks & Leisure Services Bylaw No. 2010, 2001, be amended by adding Schedules "E" and "F". **(Bylaw No. 2264, 2006)**
4. That Pitt Meadows Fee-Setting – Parks & Leisure Services Bylaw No. 2010, 2001, be amended by adding Schedule "H". **(Bylaw No. 2385, 2008)**
5. That Pitt Meadows Fee-Setting – Parks & Leisure Services Bylaw No. 2010, 2001, be amended by deleting Schedules "A", "B", "C", "D", "E", "F", "G" and "H" in their entirety and replacing with Schedule "A", "B", "C", "D", "E", "F", "G", "H" and "I" as attached hereto. **(Bylaw No. 2487, 2011)**
6. This Bylaw shall come into force and effect as of January 1, 2012 for Schedule "A", "B", "C", "D", "E", "F", "G", "H" and "I". **(Bylaw No. 2487, 2011)**
